



LABELLING INSTRUCTIONS FOR CANS

9/2021

- Labelling cans is permitted for small product batches
- Cans can be labelled either fully or partly
- Because the barcode is scanned automatically by reverse vending machines, special attention must be paid to the quality of label printing (barcode) and adhesion
- Can markings according to marking instructions
 - Barcode, deposit marking, material marking
 - Size, quality
- A labelled can product is approved for the return system according to normal practices
 - A sample for Palpa also about previously approved cans that will be labelled
